LABOR AWARD

JOHN P. DUMAS

President, International Brotherhood of Electrical Workers (IBEW) Local #103

John, an active 35-year member of Local #103, has served as its President for 16 years. He has been a key player and strategist in Local 103's turnaround of recent years. John's clear vision for new and emerging markets has led to 103's strong, productive working relationships with contractors—and greatly expanded job opportunities for his 6,000+ members. John has negotiated more than 50 contracts, including complex negotiations with Harvard University and Massachusetts' Department of Transportation. In all these instances, John has expertly represented his members while earning the highest respect of those on both sides of the table. What sets John apart is his deep level of commitment to not only fight for the rights of his members on the jobsite and across the bargaining table,

but in the understanding and practical way that he supports individual members in their private lives. John also leads the Local's extensive charitable giving and community action with great caring and devotion.

MANAGEMENT AWARD

JOHN DUNLAP

Chief of Personnel and Labor Relations, *City of Boston*

As a member of Mayor Thomas M. Menino's Cabinet, John Dunlap oversees all aspects of the City of Boston's Labor Relations, Human Resources and Retirement functions. John and his team negotiate and administer contracts with seventeen unions representing twenty-four bargaining units. A talented, innovative negotiator, John collaborated with a highly-motivated coalition of Boston's municipal unions to find fresh ways to tackle complex healthcare cost issues. The result was a creative break-through agreement that delivered both good employee healthcare and a whopping \$70 million savings for the City. Prior to Boston, John was the Town

LABOR ATTORNEY AWARD

KENNETH A. GRACE, ESQ. Sandulli Grace PC

Ken Grace has represented unions from the Berkshires to the Cape including police and firefighters throughout the state. Graduating from Cornell's School for Industrial and Labor Relations (ILR) in 1973, Ken earned a Master's in Labor Studies at UMass/ Amherst in 1974. Joining AFSCME District Council 93 as a business agent on the North Shore, Ken negotiated and serviced close to 50 contracts as well as regional organizing. Working full-time, he attended New England Law School at night, graduating magna cum laude. In 1982, he became

Attorney Joseph Sandulli's his first associate, and his partner in 1985. Today, Sandulli Grace's twelve attorneys represent unions exclusively. Ken's unique contribution to that growth is his humane and gifted ability to hire, manage and coach the firm's attorneys, support staff and law interns. Some of his firm's major clients include the Massachusetts Coalition of Police, the Boston Police Patrolman's Association, the Massachusetts Teachers Association and the Boston EMTs. Since 1982, hundreds of students have enjoyed Ken's "Survey of Labor Relations" one of the Labor Guild's popular, core courses. Throughout his career that commitment to labor relations has inspired and energized others.

THE BOYLE AWARD

BARRY BLUESTONE

Professor of Political Economy, founding director of the Dukakis Center for Urban and Regional Policy, and founding Dean of the School of Public Policy and Urban Affairs at Northeastern University

Growing up in a UAW family, Barry has worked with the trade union movement since he was a teenager. As a student, he helped found the University of Michigan Student Employees Union (UMSEU) in the 1960's and was a member of UAW Local 898 at a local Ford plant. Later as a professor at UMass Boston he was an active member of the Massachusetts Teachers Association. He helped develop the UAW-GM Paid Education Leave training program in the 1980s and has a long history of working with the National Education Association. Bluestone is author of hundreds of articles and monographs and co-author of eleven books that include: The Deindustrialization of America (1982), The Great U-Turn: Corporate Restructuring and the Polarizing of America (1988), Growing Prosperity: The Battle for Growth with Equity in the 21st Century (2000). In 1995, he was Special Policy Advisor to House Minority Leader Richard Gephardt working on the federal minimum wage, the Earned Income Tax Credit. labor law reform, and fair trade. He is a founding board member of the labor-backed Economic Policy Institute in Washington, D.C.
