THE BOYLE AWARD

JAMES S. COOPER Arbitrator

A labor arbitrator for the past thirty-three years, Jim got his start in neutral work as Governor Dukakis' first appointee to the Massachusetts Labor Relations Commission at age 29. He reports that the job did not pay well, but with the newly enacted General Laws Chapter 150E granting public employees the right to bargain over wages, it stirred up significant interest with cities, towns and unions. Jim enjoyed hiring over a dozen attorneys and labor relations specialists to help the agency organize the bargaining units, conduct the elections and rule on unfair labor practice charges. Much of the Commission's former staff are still active in labor relations, and Jim assures the CGA Committee that most will be attending this dinner. Jim turned his knowledge and

reputation into a career as an ad hoc and panel arbitrator and has been busy hearing cases and writing awards ever since. He has been a member of the Labor Guild's faculty. teaching arbitration since 1984 where he continues to draw rave reviews by producing a never ending stream of colleagues as quest speakers. Jim lives in Brookline with his wife of 27 years Susan Horwitz, a partner in the law firm of Sandulli Grace, along with his son William, a senior at Brookline High School. His daughter Phoebe, a recent graduate of Union College, lives in New York City.

MANAGEMENT AWARD

JOHN F. TORPEY JR. Director, Corporate Labor Relations, *Raytheon Company*

As Director of Corporate Labor Relations, Jack Torpey is responsible for the strategic coordination of all collective bargaining activity for Raytheon's four domestic businesses and its International and Business Development operations. Raytheon, a legendary pioneer in Route 128's Massachusetts Miracle of innovation and high tech manufacturing, is a \$24 billion, 68,000 employee global company, specializing in defense, homeland security and other primarily governmental markets internationally. is responsible for negotiation and implementation of all corporate-wide initiatives, as well as all LR activities, decision-making and effects bargaining related to any M&A and restructuring that Raytheon undertakes. Jack joined Raytheon in 1990 as Manager of its self-insured worker's compensation program covering 20,000 workers in MA and RI. In 1993, he became Manager, Labor Relations, where he negotiated and administered 12 labor agreements with unions performing work on behalf of Federal Government agencies. Prior to joining Raytheon, he served as Assistant General Counsel for the Mass Turnpike Authority and as an associate at Murphy and Beane. A University of Massachusetts at Boston graduate, he received his JD from Suffolk University Law School. Jack served 33 years as a military Reservist, initially as a Crew Chief with the Air National Guard, then as a JAG with the Massachusetts Army National Guard, where he served 3 years as the Staff Judge Advocate (SJA). He retired from the US Army Reserve in 2011 at the rank of Lieutenant Colonel (LTC).

LABOR ATTORNEY AWARD

D. M. MOSCHOS, ESQ. Partner, *Mirick O'Connell*

As a senior partner in the firm's Labor, Employment and Employee Benefits Group, D represents and advises private and public sector management on labor and employment law issues. He has personally conducted more than 600 labor negotiations, including negotiations involving teachers, factory workers, hospital employees, and public employees. He represents management in labor and employment cases before the NLRB, the Department

of Labor and the MCAD. His colleagues note his profound respect for organized labor and its efforts on behalf of its membership, and hail the impact of D's professionalism, values and integrity on his exceptional mentoring of their firm's Associates.

D is a fellow of the College of Labor and Employment Lawyers which includes the nation's leading labor lawyers, and has been named one of Massachusetts "Super Lawyers" by Boston magazine and Law & Politics every year since 2006. A founder and former management chair of the State Joint Labor Management Committee (Dunlop Commission), D drafted a portion of the Massachusetts Labor Statute, and the first Massachusetts municipal regulations governing biomedical research.

His tireless work for many charitable and faithbased organizations includes service as President of Catholic Charities of Worcester, and as Special Counsel to the Greek Orthodox Archdioceses of Boston and New York and Hellenic College.

LABOR AWARD

JULIE BETTS PINKHAM, RN,

Executive Director, Massachusetts Nurses Association (MNA)

As MNA's Executive Director, Julie Pinkham represents over 23,000 Massachusetts nurses. Early in her career, Julie served as chair of the bargaining unit of nurses at the University of Massachusetts of Worcester. and was also involved in the bargaining unit at Brigham and Women's Hospital. In 1989, Julie became a MNA Business Agent. In 1995, as MNA's Labor Program Director, Julie's ability as a strategist and brilliant explainer of issues to leadership and rank-andfile was widely recognized. In 2000, MNA's Board of Directors (29 direct care nurses elected by members) hired Julie as their Executive Director. "Julie oversees our MNA staff, and is our chief operating officer," MNA President Donna Kelly-Williams says. "She's a great leader and activist for nurses – and healthcare for all. Julie empowers people, and continually encourages members to step up and become leaders. I call her "Miss Cleo" because of her incredible ability to see into the future well before an issue or situation is on anyone's radar." In 2012, in addition to her MNA duties, Julie served as interim Executive Director for the New York State Nurses Association (NYSNA) where she guided their 35,000 members to realize a longtime goal of being a union run by, and for, staff nurses. "True to her roots and sense of fairness, she's led the patient safety fight based on her deep knowledge of the healthcare sector," Eileen Norton, MNA's Director of Organizing notes. "Every day, Julie fights for our members, and she's provided so much of the vision, guidance and education that has moved MNA forward."
