LABOR AWARD

WILLAM D. McLAUGHLIN President and Business Representative, International Union of Operating Engineers (IUOE) Local #4

Even as a young Catholic Memorial student and quarterback, Billy McLaughlin's life goal was to join the ranks of his dad Dennis, uncles and cousins who were skilled operating engineers and proud members of IUOE Local 4. Graduating from Local 4's demanding four-year apprenticeship program in 1991, Bill earned the muchcoveted Joseph Grande Award as Top Apprentice Engineer. An outstanding equipment operator, Bill worked on the Big Dig and Deer Island. Elected to several Local 4 positions, he served as a Conductor, Convention Delegate, and Executive Board member.

Now President, Bill chairs Local 4's Executive Board and Body meetings, and is Boston's Business Representative. He is a Trustee of the Union, and their Pension and Annuity and Savings Plans.

Bill is held in high regard by his peers in construction and labor relations for his thoughtful professionalism, integrity and deep industry knowledge. A skilled and effective negotiator, he is a strong, vigilant advocate for his members' interests, and works tirelessly to secure new work opportunities.

THOMAS J. RYAN III Director of Employee-Labor Relations, National Grid

Tom Ryan is responsible for negotiating and administering seventeen collective bargaining agreements for National Grid. Tom works closely with four international unions representing 18 locals: the Steelworkers (USW), the Utility Workers (UWUA), the IBEW (Electricians) and the Teamsters (IBT).

Raised in Lynn, Tom is a 1985 graduate of Union College in Schenectady NY where he played Division 1 hockey. After graduating, he was Assistant Hockey Coach for a year, and Chief Recruiter the following season. Tom received his MBA for Northeastern University in 1992.

Returning home in 1987, Tom joined Boston Gas as a meter reader, then a Marketing Coordinator in 1988. He helped launch Boston Gas' first-in-the-nation home energy conservation program (now Mass Save) as a Supervisor in 1990, then as the program's Manager in 1992.

LABOR ATTORNEY AWARD

SHELLEY B. KROLL, ESQ. Partner, Segal Roitman LLP

Shelley joined Segal Roitman in 1985, becoming a partner in the firm in 1992. She knew Segal Roitman was the place for her after spending a semester working there while attending Boston College Law School. After graduating from BC summa cum laude in 1984, Shelley served as a law clerk for Edward Hennessey, then Chief Justice of the Supreme Judicial Court, returning to Segal Roitman at the year's end.

Her union clients represent workers in a wide range of industries, including garment shops, distribution centers, industrial laundries, food service, manufacturing, telecommunications, and academia.
