## WINTER YOUNG WORKERS' WORKSHOP SERIES

### Examining the challenges and circumstances facing today's young workers

On February 5th, the Labor Guild kicked off a four-session FREE Young Worker Workshop Series on Monday nights for younger people in the labor movement (between the ages 18-39). As we go to press, the first three nights of the workshop series welcomed over 50 attendees from more than 20 different unions and community groups.

Young workers in Massachusetts are coping with an economic and political system that's almost unrecognizable from that of their parents' generation. We assembled panelists from a variety of unions, trades, and community organizations with successful campaign models to discuss critical issues impacting young workers. Continued on pg. 4

MANAGEMENT ATTORNEY AWARD

MARK BATTEN, ESQ.

Partner, Proskauer

First I'm obviously very thankful to the Labor Guild for thinking me worthy of standing up here with my fellow nominees and with the impressive list of lawyers for both unions and management who have won this award in the past. It's an honor to be added to that list. I'm also grateful to my clients for the endlessly challenging and rewarding work that you have permitted me to do. I appreciate more than you know the trust that you have invested in me.

I find too that the process of collective bargaining involves negotiating with your clients almost as much as the people on the other side of the table, and I appreciate your willingness to put with my nudging as we tried to accomplish what we needed but still get to an agreement. I'm grateful too to the unions and the lawyers and representatives who have been on the other side of the table from me, who made me look good more times than I can count. After the necessary table pounding on both sides, I generally have found people interested in working constructively to get to agreements that we all can live with. It doesn't have to be that way, and the cooperation we

have had, albeit sometimes at the end of a long day, has made me more successful, so I thank you for that.

Lawyering is about advocacy, and one of the challenges of being a lawyer is giving the strongest possible voice to a client whom you may think, objectively speaking, is in the wrong. Perhaps the chief blessing of representing newspapers is that I almost never have to feel that way. Maybe on a particular issue here or there, but fundamentally, the newspaper business is one that I never have to feel conflicted about defending. From investigating the powerful to sharing the stories of everyday people, newspapers provide the information we need to function as a democratic society.

And in these times, just as newspapers are becoming even more essential as a check on the extremes of those in power, separate economic forces are threatening their existence. As circulation and advertising continue to decline, newspapers are being deprived of the means to carry out their vital responsibilities. It is all the more important as newspapers' position becomes ever more precarious, that labor and management face these challenges together, in the spirit that animates the work of Boston Labor Guild, cooperating to manage circumstances forced on both of us from outside. This is no longer about how much profit ownership will share with its employees, but rather about how labor and management together can confront and resist the forces that threaten to deprive both sides of their ability to continue in this important enterprise. I look forward to working with both sides to achieve that common goal.



# AUXILARY – THE FR. EDWARD F. BOYLE, S.J. AWARD

**DAVID WEIL, PH.D.** 

Dean and Professor, Heller School for Social Policy & Management, Brandeis University

Former Administrator, Wage & Hour Division, US Department of Labor

I am deeply honored to be here tonight for many reasons.

First, I am honored by the award because of its namesake, the late Father Edward Boyle. I was working on my PhD dissertation back in the mid-1980s when I had the good fortune to first meet Father Boyle... at the Harvard Trade Union Program where he (taught) a class and (always gave the Graduation invocation)...He would invoke social justice, fellowship, the honor of workers, the principles of unionism and civil rights, and the fellowship of men and women all in a two minute span. And, memorably for me as a Jew, he would do so (in a way that made) all people ... feel part of the fellowship he described.. (He) involved me in the Labor Guild and always tried to ...help (my work) matter to working people in Boston and at the Guild.

Second, I am deeply honored to add my name to the list of (past Boyle Award recipients)... (such) as John Dunlop, Jim Healy, Charles Myers, and more recently Arnold Zack, Tom Kochan, Elaine Bernard, Bob McKersie, Rosemary Pye, and most recently my former

DOL colleague Mike Felsen.

Two people who could not be here physically, are my parents, Jerry and Nancy Weil who still live in my other hometown, Greeley, Colorado. They are my inspiration... and also my north stars...My mother's parents came to this country around 1905, starting as garment workers and building a family here. My father's family came to this country as refugees, fleeing Nazi Germany in 1939. They were fortunate to have a sponsor in this country at a time when the doors were closing with devastating consequences to those who could not escape Europe.

My mother's and father's family stories and my existence is a testament to the promise of this country. It represents the best of America—the nation that, in its greatest moments ...welcomed refugees from around the world and provided opportunity for their families; a nation that has sought to right its own deep wrongs in addressing the wounds inflicted on African Americans and Native Americans.

It is the same nation that ... for decades... (led) the world in economic growth and productivity improvement, (and shared that growth by an) improvement in real earnings and economic opportunity. A large part of that is the story of collective bargaining that people in this room care so deeply.

The aspirations that mark this evening and characterize the work that so many of you do in labor, management, government, academia, and as neutrals are sadly under fire now both because of our political situation and longer term changes in the structure of our economy and workplace.

Receiving this award honoring Father Boyle and his legacy reminds me of the importance of never giving up on those aspirations and dedicating our heart, mind, and soul to the task of bending the long arc of history to justice.



## LABOR AWARD CYNTHIA A. RODRIGUES

President, Greater Southeastern

Massachusetts Labor Council, and

New England Joint Board UNITE HERE

I am proud to have union organizing in my blood. At age sixteen I started working in a union garment factory in Fall River. I was glad to enter a union shop. We worked hard to create solidarity, trust, and unity to win a contract and act together. I would like to thank my fellow garment workers who put their trust in me. They took risks, not only against the intimidation of the bosses, but sometimes in defiance of their own husbands... Strong women - Including my hardworking determined mother-- played a role in my life and they were my role models.

Although there were many women who were leaders in the labor movement, not all labor officials allowed women to rise to official leadership positions. Both Ed Clark and Warren Pepicelli had faith in me as a union leader (and negotiator.) I want to thank Ed for his mentorship (as) I went from being a rank and file union member to becoming a shop steward, a business agent with the Amalgamated Clothing and Textile Workers union. (Then 22 years as) one of the first women business agents in UNITE-HERE New England Regional Joint Board serving workers across New England. I also

want to thank **Warren Pepicelli**, UNITE-HERE Executive Vice President, who always... encouraged me to play roles on the UNITE-HERE NERJ Board, in our labor councils and the state federation, as well as with community organizations... (We) should never forget the constant struggle to make sure that our labor organizations truly reflect diversity in our communities.

The Labor Guild knows how faith and justice are tied together, that we must believe in each other, believe in the power of solidarity, and not be silent in any face of injustice... The Bible isn't silent about the plight of workers or the need for a living wage.

It has been a rewarding challenge to be the President of the (Greater Southeastern Mass) Council, with some days spent on the picket line and other days trying to keep politicians in line. As president of the labor council I have always known that we are stronger with community support... With coming crises, including attacks on public sector workers, including the Janus case, it is time once again to remind our brothers and sisters what it takes and took to keep our unions strong.

I want to thank my union and my biological family, because all of us have made many sacrifices that were necessary to make life more just for others. Every union local and workplace that has been organized has done so at the cost of stress and sometimes hardship. All of us have taken these risks and made this sacrifice to better our communities and for the future of our families.

I have been privileged to have the opportunity to play a positive role in so many working lives. Their struggles have made me and us stronger together and have made many friends into families. Thank you again to the Labor Guild for recognizing me tonight, it means an awful lot to me.

#### Winter Young Workers' Workshop Series Continued.



Hosted at Teamsters #25's Charlestown headquarters, each workshop addressed a different topic: Building and Energizing Futures Committees; Labor **Organizing as Community** Organizing; Politics at Work and Union Political Action; and Mobilizing and Informing Young People. Each session had a different 3-person panel of practitioners who shared their expertise and best practices, with time for frank group discussions and participant-driven growth.

On the series' first night, **Vanessa Snow** of the Greater Boston Labor Council, **Chris Sheehan** of IBEW Local 103, and **Chris Smolinski** and **Greq**  **Dodd** of Teamsters Local 25 all spoke on their experiences forming and energizing futures committees that represent and advocate for the interests of their young workers.

The following week. Matt Ruggiero of the Boston Teachers Union, Al Vega of MassCOSH, and Sarah Kelley of Mass Interfaith Worker Justice all spoke on a panel about their experience combining labor and community organizing.

Our third evening's "Union Political Action" welcomed a great panel featuring **Pablo Ruiz** from Raise Up Massachusetts and SEIU, **Annemarie McDonagh** from Massachusetts Nurses Association and **DJ Cronin** from SEIU Local 888. A dynamic group discussion covered the Janus case, union political action and organizing young workers.

Our final March 5th session on Mobilizing and Informing Young People will feature three accomplished panelists from the MTA (Teachers), 617
Media Group, and organizers from a graduate worker unionization campaign.

## SUPPORTING WORKING FAMILIES

Over the past several months, the Guild has taken on a larger role in the Raise Up Massachusetts coalition. Raise Up is a grassroots coalition of labor, community, and faithbased organizations organizing to improve the conditions of workers in Massachusetts.

The Guild, recognizing these goals as important steps to building social justice and dignity for workers, has made an effort to engage more deeply in the coalition. Last fall, we committed to collecting 500 signatures for petitions to put a \$15 minimum wage and paid family and medical leave on the ballot this November. Not only did we far exceed our goal, thanks to the Guild students, friends, and Fr. Ed Boyle Fellows who all collected

signatures, but the Raise Up Coalition as a whole collected nearly 275,000 signatures for the ballot initiatives, well over the 130,000 required by the Commonwealth.

Now that the signatures have been submitted, the Massachusetts legislature has until the summer to pass either bill. If the legislature doesn't act, both proposals will go to the ballot in November. We're looking forward to continuing our work with Raise Up and actively fighting for the dignity of workers in Massachusetts.
