LABOR AWARD Myles Calvey

Business Manager, Financial Secretary, International Brotherhood of Electrical Workers Local 2222

Born and raised in Somerville, Massachusetts, Myles and his lovely wife Janet raised their four children in Belmont, Massachusetts.

Myles started his career with New England Telephone Company in 1968 and learned from the experienced guys the value of looking out for each other. He became the shop steward and began to look after his fellow workers. He earned two degrees from Boston College, working by day and going to school part-time.

He was later elected Vice President of Local 2222, and in 1988 he was elected Business Manager. In 1991 Myles became the first Business Manager of Local 2222 ever to be re-elected. He has been re-elected every three years since.

In 2005 Myles became the first Business manager from the telephone branch of the IBEW to ever be elected to the International Executive Council. In his role as System Council T-6 Chairman, he has negotiated countless CBAs and other agreements, always standing up against corporate greed and fighting for working people.

In addition, she serves on the board of Building Pathways, a pre-apprenticeship program expanding access to building trades careers for women and people of color in Boston, Massachusetts.

Nikki began her legal career as a legal fellow in the General Counsel's Office of the AFL-CIO in Washington, D.C., and continued her advocacy of unions and individuals at Pyle, Rome, Lichten, and Ehrenberg, P.C., before joining Segal Roitman LLP. She is a graduate of Brandeis University (B.A.), the University of Illinois, Champaign-Urbana (M.A.), and Boston College Law School (J.D.). She lives with her exceptionally thoughtful, patient, and kind husband and her two precious daughters in Brookline, Massachusetts. They make all of this work possible.

John Folcarelli

Vice President Employee Relations, Student Transportation of America

Marie-Thèrése Browne, S.C.N. (Sisters of Charity of Nazareth), "Tess" or Sister Tess, is a long-time practitioner in Social Justice Organizing, beginning with the National Farm Worker Ministry assigning her full-time staff with the United Farm Workers, AFL-CIO in Wisconsin, and Texas. Tess was inspired by boycotting farmworkers who invited her to leave the classroom and join them on the picket line in solidarity with their struggle for dignity and justice. She engaged in several organizing and legislative campaigns in Wisconsin, California, and Texas, where she was Director of the National Farm Workers Service Center in San Juan, Texas. Tess co-coordinated successful campaigns to ban "El Corbito", the short, handled hoe, and to bring toilets and clean drinking water to workers in the fields. After training with the Southwest Voter Registration and Education Project farmworkers in Texas, Tess and others initiated voting rights and policy campaigns. Tess was an Organizer with the Committee for Boston Public Housing. She was statewide Organizing Director for the Mass Action for Women Audit, as a follow up to the 1995 Beijing UN Conference on Women. She was also coordinator of HELP (Healthy Environment Leadership Project), an interfaith environmental justice organizing project at Episcopal Divinity School.

John is Vice-President of Employee Relations & Compliance for Student Transportation of America, Inc., a school bus transportation company with 22,000 employees in the United States and Canada. At STA, John represents the company in labor negotiations, arbitration, mediation, and advising on employee relations matters. Prior to joining STA, John served as Deputy General Counsel for Steward Health Care System LLC, which purchased the former Caritas hospitals, including St. Elizabeth's Hospital. There John was responsible for labor, employment, and business matters. At Steward, John had a close working relationship with 1199SEIU United Healthcare Workers East, the Massachusetts Nurses Association, and the Area Trades Council, among others. Before going to Steward, John was a labor and employment attorney for First Student. That company was the successor to Laidlaw, Inc. (both school bus transportation companies), where John was Director of Human Resources responsible for the Northeast Region, including states south to Florida and Louisiana and west to Pennsylvania. John began his management career as an Examiner and later Manager of Labor Relations for Conrail's and its successor Metro-North's passenger rail operations in New York City. While working at Metro-North, John attended law school and before receiving his degree joined Morgan, Lewis, and Bockius's New York office, where he became an associate after graduating. In 1988 John moved to Milton, Massachusetts, and

IN MEMORIAM


We celebrate the lives and great accomplishments of these cherished Guilders. All were wonderful friends of the Guild. It was an honor and blessing to know each of them.

Joan (Carey) Santa Maria - With regret, we note the passing of a daughter of Dorchester who contributed immeasurably to the Labor Guild for so many years. Fr. Marc joined with Fr. John Currie of Saint Patrick Parish in Roxbury for Joan's Funeral Mass. The seven sisters- Joan's daughters- and many more family and community members joined at this gathering. Joan is remembered for her many contributions, particularly from the era of the monthly Labor Life publication.

Virginia Tisei, Esq. - Virginia was a 2003 CGA Award Winner. As a teacher in the Boston Public Schools, Virginia became active in the Boston Teachers Union. She later received her J.D. from the New England School of Law and began her career as an attorney, primarily focusing on labor relations. She worked for W.R. Grace and for the City of Boston: Consumer Affairs and Licensing as Director of Labor Relations and Director of Labor Relations for the Boston School Department. Virginia served for many years on the West Roxbury Neighborhood Council and 27 years on the Air Pollution Control Commission. Virginia was dedicated to those with developmental disabilities, serving as President of GBARC as well as a board member of the Massachusetts Association for Persons with Developmental Disabilities.

Thomas Birmingham - State Senator Tom Birmingham of Chelsea is remembered for many levels of advocacy in Massachusetts, highlighted by his 1996 election as President of the Senate. "Senate President Thomas Birmingham was an incredible public servant dedicated to moving Massachusetts forward," stated Gov. Maura Healey. "He had a towering intellect and curiosity and an ability to connect with a range of people. Though he walked through rooms of power and privilege, he stayed true to his roots and never forgot where he came from or what mattered." Senator Birmingham had kept his Labor Guild membership current since 1982.

Tom Gunning - A recipient of the 2000 Cushing-Gavin Award, SMACNA's Executive Legislative Advocate of the Year (2008, 2015), SMACNA's Chapter Executive of the Year in 2001, the Roofing Industry's Clarence Carr Award, the Boy Scouts of America "Good Scout" Award and the 1st annual Good Guy Award. His hard work was celebrated by all who knew him, and he dedicated his life to advancing the construction industry. His loss is felt by many.
